#### About the role

The Good Homes Alliance has recently expanded to cover two new pieces of work:

- 1. Development of the Welsh Zero Carbon Hwb (3-year contract).
- 2. Hosting of the **Building Performance Network**.

Due to this continued growth, we are seeking an entrepreneurial **Business Development Associate** to support the GHA Programmes Director, as part of the GHA's small but impactful team. They will also have a hands-on role with a particular focus on the development of new, and growth of existing, workstreams.

The role could also include working with Building Performance Network to manage and support their BPE workstream and Pioneer Network as **BPN Network Lead**. Experience of building performance evaluation would be desirable for this role.

Applicants would be welcome to cover both GHA and BPN activities, or we would consider applications for either part of this role separately. Please indicate which parts of the role you would seek to cover, when you apply.

Specific tasks are likely to evolve, but include:

- I. Recruitment of new members. This is a priority.
- 2. Liaison with existing members and potential members.
- 3. Support of: (via membership recruitment, strategic planning)
  - a. all GHA networks, Vanguards/Pathfinders/BPN/SME Developers.
  - b. development of BPE workstream, including providing BPN representation on the Future Homes Hub BPE workstream.
  - c. Potential development of a retrofit workstream.
- 4. Identifying growth opportunities via research, collaboration, projects, commercial opportunities.
- 5. Managing and supporting the BPN Pioneer network, the Advisory Panel and its membership.
- 6. Bid writing (as part of a team).
- 7. Advocacy via forums and speaking opportunities.
- 8. Assisting team with development and supervision of research projects.
- 9. Assisting team with development and supervision of education events.
- 10. Inputting into GHA Marketing & Development activities, including, press/pr and other marketing activities.

#### **Contract arrangements:**

The contract could be on a self-employed basis or via a PAYE contract. It is envisaged that the role will start as part time at 4 days per week and will be home based (one day is assumed to be approximately 8 hours). Travel expenses will be paid.

The appointment will initially be for 12 months with review points at month 3 and 10 or earlier, where the contract could be extended. Salary is proposed as £45k - £50K negotiable pa. FTE pro rata dependent upon experience.

We are also open to part-time or flexible working or job share arrangements. We would welcome any applicants who would just like to take on either the GHA or BPN role part time (2 days pw each).

The Good Homes Alliance (GHA) has been set up to transform the way we undertake new house building, and how we improve, monitor and measure high performance net zero homes in the UK. The GHA works to make a step change in practice by proving that it is possible to change mainstream practice by building large numbers of exemplary homes in exceptional communities in a commercial way; we provide forums and support for those who are determined to build to net zero standards now. The GHA actively promotes this way of doing things through research, events, campaigns, PR, seminars, education programmes etc, and will seek to influence government, landowners and other influential people and bodies to normalise this change through best practice, legislation, guidelines and financial incentives.
